#### John Lally, APRN & Executive Director of Today I Matter



John Lally, APRN, is a Psychiatric Nurse Practitioner from Ellington with a private practice in East Windsor and is a member of the American Society of Addiction Medicine. He is Executive Director of Today I Matter, a non-profit organization started in tribute to his son, Timothy, who died last year from a heroin overdose. His group is dedicated to reducing the shame and stigma of mental illness and addiction, while promoting the mental, emotional, and physical health of the community. He has been featured on area television news programs, and has spoken for the State of Connecticut Department of Public Health, as well as many local town forums regarding the current opiate epidemic.

Karen Colt is a Licensed Alcohol and Drug Counselor and is the Program Director of Natchaug's Rivereast Day Treatment Program in Vernon. In her nearly 20 years of work in the field of substance abuse and mental health, she has had the opportunity to work with children, adolescents and adults in outpatient, ambulatory, residential, and inpatient programs. She is an advocate for Medication Assisted Treatment for opioid use disorders and a strong proponent of making Narcan widely available in the community.

## **Steven Jackson**, CAC, MATS, Hockanum Valley Community Council, Inc.



Steven is a Certified Addiction Counselor and Medication Assisted Treatment Specialist. He currently works as the Coordinator for Hockanum Valley Community Council's Suboxone Program in Vernon. He has been active in the field of non-profit social services for nearly a decade, working in both intensive inpatient and outpatient addiction treatment settings. Steven is also active on Vernon ROCKS Coalition, serving as a substance abuse expert.

#### Matthew Gedansky, State's Attorney, Judicial District of Tolland

Matthew has been the State's Attorney for the Judicial District of Tolland since 2003. In this role, he is responsible for the investigation and prosecution of all criminal and motor vehicle violations arising within the district's 13 towns.
