RHS PRIDE Survey Data

In June The Vernon ROCKS Coalition administered a PRIDE survey to the entire 2018-2019 RHS student body. PRIDE is a tool that is used to measure protective and risk factors including youth substance use. The results show that the most common substances used in the past 30 days were as follows:

- 1. E-cigarettes and vapes (**32.4%** reported past 30 day use)
- 2. Marijuana (24.5% reported past 30 day use)
- 3. Alcohol (20.7% reported past 30 day use)

The main places these substances are consumed are at home and friends' houses. It is imperative that parents and kids have open conversations that encourage and promote protective factors that ensure kids remain substance-free! Learn how on our <u>REAL TALK</u> page.

Tobacco Compliance Checks



In August we partnered with The Vernon Police Department to conduct tobacco compliance checks. Eight establishments were caught selling tobacco products to minors out of the 27 checked. The compliance checks involved minors, working under the supervision of authorities, attempting to purchase tobacco.

Police said the eight establishments that sold tobacco to minors were:

- Discount Cigarettes & Cigars, 96 Hartford Turnpike
- Smoker's Paradise, 458 Talcottville Road
- · Vernon Shell, 520 Talcotville Road
- · Family Dollar, 42 Windsor Avenue
- · Sam's Food Store/ Gulp, 41 Windsor Avenue
- Total Express, 24 West Street
- · Citgo/ Erums Mini Mart, 81 Union Street
- Discount Tobacco & Vape, 30 Lafayette Square

Compliance checks are conducted to address enforcement of tobacco laws, making tobacco less accessible to minors, especially with the minimum age to purchase tobacco in CT is increasing to 21 starting October 1st. The Vernon Police Department and Vernon ROCKS Coalition thank the establishments who were in compliance and did not provide tobacco to minors.

DEA Drug Take Back Day

BPS hosts this race annually to raise money to provide inpatient acute care, post inpatient rehabilitation, and postrehabilitation housing for alcoholics and addicts who are in need.

Narcan and QPR Training

On September 12th we held a Narcan and Suicide Prevention Training at the Rockville Public Library. Narcan (Naloxone) is an opioid overdose reversal drug that when administered

can save a life. The training covers overdose prevention strategies, signs and symptoms of overdose, how to administer Naloxone, and information on the Good Samaritan Law. The suicide prevention training was based on the QPR model, which stands for Question, Persuade, and Refer. It highlighted warning signs of people contemplating suicide, strategies on how to approach the topic with someone you might be concerned about and information about additional support and resources.

I specifically chose to work in substance abuse prevention because substance abuse affects so many people, and too many times results in premature death. If we can work together to prevent young people from abusing drugs and alcohol, we can help increase the likelihood that they will live long, healthy lives." What is your hope for the coalition?

"My hope is that the coalition can continue to increase in size and scope, continuously increasing the programs and activities we provide to the community. I hope that we are able to sustain our efforts, with or without additional grant funds."

What has been your favorite event the coalition has done this year, why?

"My favorite Vernon ROCKS event has been our annual Rockville ROCKS block party. I enjoy see all our community partners come together for a fun, free and information event for the community."

What have you learned from the coalition?

"I've learned a lot about Vernon and a lot about substance use trends in town. It's so interesting learning from different community partners like the police department and our members who work in the schools, the teenagers on the coalition, our partners who are in recovery, and those who treat individuals with substance use disorders."
